Terms & Conditions for Fundi Technology (Pty) Ltd t/a www.topitup.io

1. Overview

These Terms & Conditions ("Terms") govern the sale of prepaid digital vouchers (voucher codes) via www.topitup.io. Fundi Technology (Pty) Ltd (trading as Topitup.io) is a South African company and the merchant of record for all transactions. By purchasing vouchers on this Site, you agree to comply with South African law, including the Consumer Protection Act, 2008 ("CPA"), the Electronic Communications and Transactions Act, 2002 ("ECT Act"), and these Terms. All vouchers are denominated in South African Rand (ZAR) and delivered electronically. No physical goods are shipped – after payment, you receive a unique code usable at the partner service provider.

2. Country of Domicile

Topitup.io is based in the Republic of South Africa. All sales are governed by South African law, and any delivery or usage of services must occur within South Africa. You acknowledge that by using this Website, you are a South African consumer (or are acting under South African law).

3. Goods/Services

We sell single-use digital vouchers (prepaid electronic codes) denominated in ZAR,

redeemable for goods or services offered by our partner platforms. These vouchers function as a payment method and are delivered by email or via your online account immediately after successful payment.

4. User Account Management

4.1. **Registration and Accuracy:** To access certain services on www.topitup.io, you may be required to register an account and provide accurate, current, and complete information. Fundi Technology (Pty) Ltd bears no liability for any costs or issues arising from incorrect details provided by you. You are responsible for ensuring your account details remain updated.

4.2. Account Security: You are solely responsible for maintaining the confidentiality of your login credentials, including your password, and for all activities that occur under your account. You must use strong passwords and not share them. You agree to immediately notify Fundi Technology (Pty) Ltd in writing of any unauthorized use of your password or account, or any other suspected security breach.

4.3. Account Suspension and Termination: Fundi Technology (Pty) Ltd reserves the right to suspend or terminate your account at its exclusive discretion if it reasonably suspects corrupt, illegal, fraudulent, or abusive activity, or any violation of these Terms. We may investigate such activities without prior notice and keep the account suspended until the investigation is finalized. Fundi Technology (Pty) Ltd will reactivate accounts only after being satisfied that no illegal activity is linked to them and reserves the right to verify accounts before reactivation.

10. Dispute Resolution

10.2. Alternative Dispute Resolution (ADR): If a dispute cannot be resolved through direct engagement with our customer service, Fundi Technology (Pty) Ltd encourages the use of Alternative Dispute Resolution (ADR) mechanisms. ADR offers a more efficient, confidential, and cost-effective means of resolving disputes compared to traditional litigation.

10.2.1 Negotiation: This involves direct discussions between the disputing parties to reach a mutually acceptable agreement.

10.2.3 Mediation: A neutral third-party mediator facilitates constructive dialogue between the parties, helping them to clarify misunderstandings and explore mutually acceptable solutions. The mediator does not impose a decision but assists the parties in reaching their own voluntary, legally binding settlement.

10.2.4 Arbitration: This is a more formal process where parties agree to submit their dispute to a neutral arbitrator (or panel) who hears evidence and legal arguments and then makes a binding and legally enforceable decision.

11. Electronic Transactions and Signatures

11.1. **Legal Recognition:** Electronic signatures are legally recognized in South African Law as provided for by the Electronic Communications and Transactions Act (ECT Act). An "electronic signature" means data attached to, incorporated in, or logically associated with other data and which is intended by the user to serve as a signature.

11.2. **Types of Electronic Signatures:** Examples of electronic signatures include your typed name at the end of an email or a scanned image of your handwritten signature embedded into a document. An Advanced Electronic Signature (AES) is a digital certificate-based signature that utilizes mechanisms to ensure security and integrity and to confirm and verify the identity of the signatory.

11.3. **Consent:** The use of electronic signatures is valid only with your explicit consent. By using this Website and proceeding with any transaction, you provide your voluntary, specific, and informed consent for the use of electronic communications and signatures.

11.4. **Agreement of Sale:** An agreement of sale on www.topitup.io is concluded when you electronically submit a completed order (e.g., by clicking "Proceed with request") and Fundi Technology (Pty) Ltd subsequently electronically confirms receipt of your request.

12. Specific Considerations for Digital Voucher/Service Sales

12.1. Voucher Validity and Expiry:

12.1.2 Purchased Vouchers: In accordance with Section 63 of the Consumer Protection Act (CPA), purchased vouchers generally expire after a period of 3 years from their date of issue.

12.1.3 Promotional/Complimentary Vouchers: Promotional or complimentary vouchers may have a shorter validity period, typically 6 months from the date of issue.

12.1.4 Non-Expiring Vouchers: If Fundi Technology (Pty) Ltd offers "Rand Vouchers" or similar products designed to retain their value indefinitely, this will be explicitly stated as a key feature of the product.

12.1.5 Value Adjustment: If the cost of the underlying service or product for which a voucher is redeemable has increased since the voucher's purchase, the voucher holder may be required to pay the difference upon redemption.

12.1.6 Safety and Non-Replaceable: Vouchers are valuable documents and should be

kept safely and securely. Fundi Technology (Pty) Ltd cannot be held liable if a voucher is lost, stolen, destroyed, or used without permission, as they are generally not replaceable. The person who holds the voucher will be regarded as its owner.

12.1.7 Single Use: Each voucher is typically redeemable only once and cannot be split for multiple transactions unless explicitly stated otherwise.

12.1.8 Merging Vouchers: If applicable, the policy for merging multiple vouchers, including any associated administration fees (e.g., R200), will be detailed, and the new voucher will carry the expiry date of the earliest merged voucher.

12.2. Non-Exchangeable/Non-Refundable Clause (with Statutory Exceptions):

12.2.1 While voucher purchases are generally considered final once the digital code is delivered and are non-exchangeable and non-refundable, this policy is subject to your statutory rights as a consumer under the CPA and ECT Act.

12.2.2This means that if you are entitled to a refund or exchange under applicable South African law (e.g., for defective goods, during a cooling-off period, or if required by a customer's legal right under the CPA), Fundi Technology (Pty) Ltd will comply.
